#### **PLSD Finishes Improvement Project**

PLSD completed expansion portion of the project over the summer and fall by connecting 56 additional cabins to the sanitary sewer system. The system is fully functional and operating now. PLSD is working with the general contractor to finish a few outstanding items related to remediation work followed by a state inspection for final certification. It's been a long journey, but worth it. Thanks to all of you for your cooperation and patience!

#### **PLSD Contracts For Snow Removal**

With technology integrated in the new main lift stations, PLSD can monitor them remotely. With this new feature, PLSD will no longer need to maintain an open road to each of the 13 lift stations after a substantial snow fall. ## **PLSD Allows Sump Pump Discharge During Winter**

PLSD Ordinance 13 allows sump pumps to discharge into the sanitary sewer system November 1<sup>st</sup> – April 1<sup>st</sup>. Customers in need of sump pumps over the winter months should move their sump pump discharge hoses to the outside by April 1st. PLSD reminds you that you must complete a sump pump permit as required by the ordinance. You can find the permit form under the Customer Information section under Rates and Fees.
